

The Private Medical College should Provide Bank Guarantee of required amount against Increase of seats of course 5 Seats in favour of National Medical Commission, New Delhi valid for three years or till the course is recognised, whichever is later, from a nationalized/scheduled Bank as per NMC/MCI's norms. However, medical colleges/institutions governed by the State Govt. are required to furnish only an undertaking signed by Govt.
